2012

July OCBC sells stakes in Fraser & Neave and Asia Pacific Breweries to parties linked to Thai tycoon Charoen Sirivadhanabhakdi.

Nov Straits Trading announces intention to take over technology, property and motor group WBL as its stake in WBL rises after completing deals with two funds.

Dec United Engineers (UE) buys 79 Anson Road freehold building for S\$410m (renamed UE BizHub Tower).

Jan UE makes a S\$4-a-share counter-offer for WBL over Straits Trading's S\$3.36-a-share offer.

Mar UE raises WBL offer to S\$4.15 a share; Straits Trading lets own offer lapse, says no intention to sell its stake.

May UE makes final S\$4.50-a-share offer for WBL; Straits Trading accepts; UE gets WBL which includes Wearnes, MFlex, MFS.

June UE proposes 1-for-1 rights issue at S\$1.50 a share to reduce debt load after WBL takeover.

July UE sells leasehold UE BizHub East in Changi for S\$518m to Viva Industrial Trust.

Sept UE buys two Alexandra Road freehold buildings for S\$402m (renamed UE BizHub West).

Jan UE has hired a bank to value WBL's Wearnes automotive portfolio.

Aug UE sells WBL tech subsidiary MFS Technology for S\$124m.

Aug Discussions by OCBC to sell UE stake to Mr Charoen prompt UE share price surge.

Aug UE sells WBL's Wearnes unit for S\$455m.

Oct UE sells engineering and construction subsidiary UE E&C for S\$230m.

Feb Talks between OCBC and Mr Charoen on UE sale fizzle out due to price disagreements.

Feb UE sells WBL's Multi-Fineline Electronix (MFlex) for S\$505m.
