- **GIC** and **Vingroup** invest US\$203m in the Vietnamese private hospital operator Vinmec
- **TPG Growth** buys Apollo Hospitals Dhaka for US\$118m
- KKR-controlled **Max Healthcare** buys controlling stake in Saket City Hospitals
- **Bain Capital** buys Nichii Gaakan, a Japanese provider of senior care, for US\$1.6b
- **STIC Investments** buys S.Korea weight loss consulting chain Juvis Diet for US\$211m
- **BGH Capital** buys Australia's Healius for US\$343m
- **Livingbridge** invests in Adelaide-based Better Medical and Smart Clinics
- **BGH Capital** buys Australia's Healius' 70-odd medical practices for US\$342m
- **Loyal Valley Capital** invests US\$186m in CARsgen Therapeutics
